Re: INVITATION TO TENDER

We have the vehicle(s) (please refer to the attached Tender Form for details) to be sold by way of tender. You are invited to tender for the vehicle(s) through the attached Tender Form and conditions of which are as follows:-

1. The vehicle is sold in its present conditions on an "as is" basis. It can be inspected at the designated location(s) as stated in the attached Tender Form at any time during office hours. Any person desiring to tender for the vehicle will, whether or not he/she inspects the vehicle, be deemed to purchase the vehicle with notice of all defects and faults therein and shall not reject the same on the ground of any defects and faults in quality or road-worthiness or they do not conform to description or they are not fit for any purpose. Every expressed or implied warranty or condition as to its genuineness authenticity or in any other aspect, statutory or otherwise is hereby excluded.
2. We do not warrant that the ownership of either the vehicle or the license thereof can be transferred to the successful tenderer.
3. We reserve the rights to retain the captioned registration mark.
4. We do not undertake to accept the highest or any tender and reserve our rights to withdraw such invitation for tender at any time.
5. Once a tender is made and forwarded to us (by hand, facsimile or e-mail), it cannot be withdrawn.
6. If any tender is accepted, the tenderer should immediately make arrangements to comply with all statutory requirements before taking delivery of the vehicle. Deliveries of the vehicle must be taken within 3 days after notification of the acceptance of the tender is being made to him and in default of such taking delivery from the designated location(s), you shall be in breach of this tender which entitles us to forthwith terminate any agreement reached with you on the sale of the vehicle, and we shall be entitled to resell the vehicle to such other person and at such price and subject to such stipulations as we may think fit and any increase in price on resale shall belong to us.
